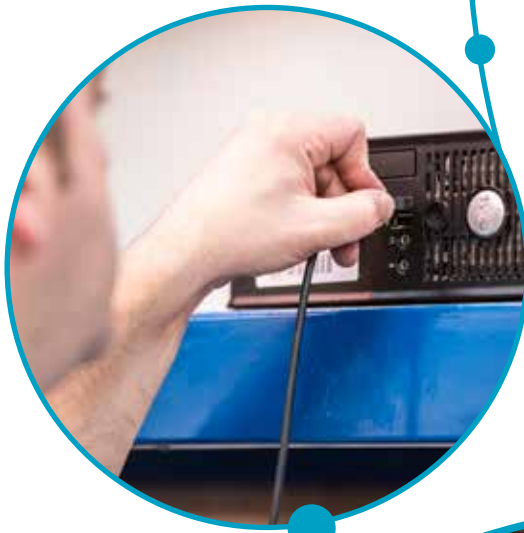

Often the IT assets are written-off simply because organisations don't possess the in-house expertise or equipment to securely wipe their IT assets to a sufficient level. At other times, IT Assets are disposed of due to no longer being in warranty. In addition there are numerous legislative and regulatory requirements that are placed on organisations when managing confidential data.

AMI has developed a service to provide our customers with a straight forward solution to the complex challenge of ICT asset disposal.

AMI recycle all types of IT and technology equipment which is broken, obsolete or no longer fit for purpose. Our service helps our customers efficiently dispose of all types of redundant IT and electrical equipment including CRT units (TVs & Computer Monitors), PC Base Units, Keyboards, Printers, Photocopiers, Fax Machines and Miscellaneous Electronic Equipment.



Safely Collecting | Erasing | Re-Using IT

AMI will collect your redundant and end-of-life IT assets from your premises, throughout Ireland. Security is at the forefront of AMI so collections will be completed in AMI's un-marked vehicles, by fully trained AMI staff in uniform. Our vehicles are locked and attended at all times and are fitted with GPS tracking.

We have a range of vehicles available for collections including vans, 7.5 ton lorry, 12 ton lorry and 40ft collections.

Your assets are then transported to one of our two facilities based just outside Dublin and the other near Belfast.

On arrival at our facility, all powered items are tracked at point of processing in AMI via our bespoke tracking system, giving you the ability to track the status of your assets. This includes the recording of...

- Item type
- Asset Tag / Serial Number
- Collection Date & Site
- Item Specification
- Make / Model
- Processing Details

Collecting | Securely Erasing | Re-Using IT

The data protection act requires all information to be destroyed when the media on which it is stored becomes redundant. Therefore every business has an obligation to keep its customer and employee data secure. Data leaks create negative publicity and often lead to sizeable financial penalties. AMI can help its customers avoid these very real risks with our guaranteed 100% secure data erasure.

By utilising Blancco software, we ensure all of your data from your IT Assets are securely and completely destroyed prior to remarketing or recycling. Data erased by Blancco is permanent; it cannot be recovered. Blancco wipes each drive 3 times before passing it as 100% successfully erased. This in turn allows the IT Asset to be safely remarketed by AMI without any risk of remaining customer residual data, protecting against fraud and loss of sensitive company data.

Any hard disk drives or data bearing devices that cannot be successfully wiped or are not suitable for remarketing, are disposed of using the AMI's mobile shredding service. This literally shreds all storage media into debris no larger than 20mm in diameter providing guaranteed destruction of customer data. All failed items are scanned from unit and tracked into the shredder. The 'Certificate of Destruction' issued after every shredding process is proof that Secure Destruction of Confidential Material has been completed in full compliance with the EN 15713:2009 accredited standard.

3. We provide an agreed revenue share back to the customer on remarketed IT assets. This ultimately releases an end-of-life value back to the customer

The remarketed IT assets are tracked from the initial collection at a customer site through to the onward sale with our bespoke asset tracking system which delivers a comprehensive audit trail for each individual ICT Asset. A Certificate of Destruction is issued to guarantee the items have been recycled.
